1.1 Registrant(s) (defined below) interested in purchasing the specified residential properties will be divided into 2 groups:-

1.2 The minimum number of specified residential properties described in paragraph (1)(i)(a) of the Conditions of Registration under the Registration of Intent means the corresponding minimum number of specified residential properties specified in the above paragraph 1.1 that the Registrant must purchase according to his/her indication to participate in Part 1, Part 2 or Part 3 of Group A on the First Date of Sale. For the avoidance of doubt:-

(i) The minimum number of specified residential properties described in paragraph (1)(i)(a) of the Conditions of Registration under the Registration of Intent in respect of a Group A Registrant who indicates on the First Date of Sale that he/she participates in Part 1 of Group A shall be 5;

(ii) The minimum number of specified residential properties described in paragraph (1)(i)(a) of the Conditions of Registration under the Registration of Intent in respect of a Group A Registrant who indicates on the First Date of Sale that he/she participates in Part 2 of Group A shall be 3; and

(iii) The minimum number of specified residential properties described in paragraph (1)(i)(a) of the Conditions of Registration under the Registration of Intent in respect of a Group A Registrant who indicates on the First Date of Sale that he/she participates in Part 3 of Group A shall be 2;

1.3 Where more than one specified residential property is covered in one preliminary agreement for sale and purchase, the purchaser of each such specified residential property shall comprise the same person or the same group of person.

3. To participate in the balloting, interested persons must first submit a Registration of Intent. Interested persons may call 2880 8268 (Hotline for the Development) for details of obtaining the form of Registration of Intent, which said form is also available for collection on the 1st Floor of the Designated Venue. The manner for the submission of the Registration(s) of Intent and the documents and materials required, etc. are specified in the form. Please refer to the form of the Registration of Intent for details. The order of the submission of a Registration of Intent will not have any impact on the order of priority for selecting the specified residential properties. Generally:

有意參與抽籤的人士須先遞交購樓意向登記。有意認購的人士可致電發展項目熱線2880 8268查詢有關索取購樓意向登記表格之詳情，購樓意向登記表格亦可在指定會場的1樓索取。遞交購樓意向登記之方式及所需文件及材料等於表格中有所說明。詳情請參閱購樓意向登記表格。遞交購樓意向登記次序不會影響揀選指明住宅物業的優先次序。概括而言：

3.1 Based on the selection made under the Registration(s) of Intent by the registrant(s) (“**Registrant(s)**”), each Registration of Intent may be used for showing of interest to purchase either:-

(i). More than 1 specified residential property (the Registration of Intent of this type is referred to

as “**Group A Registration of Intent**”); or

- (ii). 1 specified residential property (the Registration of Intent of this type is referred to as “**Group B Registration of Intent**”) (please note that a company Registrant can only purchase 1 specified residential property and its Registration of Intent shall be classified as a **Group B Registration of Intent**)

Subject to the rules set out in paragraphs 1.1 and 1.2 above.

按照登記人(「登記人」)於購樓意向登記中所作出的選擇，每張購樓意向登記可用以表達其有意認購:-

- (i). 多於1個指明住宅物業(此等購樓意向登記稱為「**A組購樓意向登記**」); 或
(ii). 1個指明住宅物業(此等購樓意向登記稱為「**B組購樓意向登記**」)(請注意，公司登記人只可認購1個指明住宅物業而其購樓意向登記將被歸類為**B組購樓意向登記**)，惟須符合上文第1.1及1.2段的規則。

3.2. No more than 1 Group A Registration of Intent can be submitted by each individual registrant, in sole name or in joint names with other individual(s) as a Registrant.

Group A Registration of Intent submitted by company Registrants will not be accepted. Company Registrant (which must be a company incorporated in Hong Kong) can submit only 1 Group B Registration of Intent.

If an individual registrant did not submit a Group A Registration of Intent, such registrant(s) can submit 2 Group B Registration of Intent, in sole name or in joint names with other individual registrant(s) as a Registrant.

If an individual Registrant has submitted a Group A Registration of Intent, such registrant cannot submit more than 1 Group B Registration of Intent, in sole name or in joint names with other registrant(s).

For the purpose of this paragraph 3.2: (i) for Registrant comprising 2 or more individual registrants under a Group A Registration of Intent, each of such individual registrants shall be regarded as having submitted a Group A Registration of Intent; (ii) for Registrant comprising 2 or more individual registrants under a Group B Registration of Intent, each of such individual registrants shall be regarded as having submitted a Group B Registration of Intent; and (iii) for Registrant comprising or including any company registrant(s) under a Group B Registration of Intent, each of such company registrant(s) shall be regarded as having submitted a Group B Registration of Intent.

個人登記者可以個人或聯同其他個人登記者的名義組成登記人遞交最多1份A組購樓意向登記。

所有公司登記人遞交的A組購樓意向登記將不被接受。公司登記人(必須為於香港註冊成立的公司)只可遞交1份B組購樓意向登記。

如個人登記者並無遞交A組購樓意向登記，該登記者可以個人或聯同其他個人登記者的名義組成登記人遞交最多2份B組購樓意向登記。

如個人登記者已遞交1份A組購樓意向登記，該登記者可以個人或聯同其他個人登記者的名義遞交最多1份B組購樓意向登記。

3.3 Each Group A Registration of Intent shall be submitted together with 2 cashiers' orders, each in the sum of HK\$100,000 made payable to “Baker & McKenzie”. Should the Registrant eventually using a submitted Group A Registration of Intent to purchase more than 2 specified residential properties, the Registrant shall submit the extra cashiers' order(s) drawn in the above manner to the intent that 1 cashiers' order shall be made available for part payment of preliminary deposit of each of the specified residential properties so purchased by the Registrant.

Each Group B Registration of Intent shall be submitted together with 1 cashiers' order in the sum of HK\$100,000 made payable to "Baker & McKenzie".

每份B組購樓意向登記須連同1張本票遞交，該張本票金額為港幣\$100,000，抬頭人為「貝克·麥堅時律師事務所」或“Baker & McKenzie”。

3.4 Higher priority of selection of specified residential properties will be given to Group A Registrations of Intent in accordance with the provisions in paragraph 4 below. Balloting will be used to determine the order of priority of selection of specified residential properties amongst Group A Registrations of Intent as a separate group in accordance with the provisions in paragraph 4.1 below. Balloting will be used to determine the order of priority of selection of specified residential property of Group B Registrations of Intent as another separate group in a lower priority than Group A Registrations of Intent.

A組購樓意向登記將根據以下第4段之條文獲較優先之揀選指明住宅物業的次序。A組購樓意向登記的揀選指明住宅物業的優先次序將根據以下第4.1段之條文以獨立組別抽籤方式決定。B組購樓意向登記的揀選指明住宅物業的優先次序將於另一優先次序低於A組購樓意向登記的獨立組別中以抽籤方式決定。

3.5 Notwithstanding anything as may be specified in the Registration of Intent, a completed Registration of Intent shall be submitted to the 1st Floor of the Designated Venue on or before 21 February 2017 during the following opening hours: 1:00 p.m. to 8:00 p.m. from Monday to Friday (except on 21 February 2017 the opening hours shall be 11:00 a.m. to 3:00 p.m.) or 11:00 a.m. to 8:00 p.m. on Saturday, Sunday or public holiday.

即使購樓意向登記內可能指定任何其他安排，填妥之購樓意向登記須於2017年2月21日當日或之前於下述開放時間，即下午1時至晚上8時（星期一至五）（惟2017年2月21日開放時間則為上午11時至下午3時）或上午11時至晚上8時（星期六、星期日或公眾假期）遞交至指定會場的1樓。

4. First Date of Sale:

4.1 Applicable to Registrants of Group A Registration of Intent ("Group A Registrants")

適用於A組購樓意向登記的登記人（「A組登記人」）

- (i). The balloting to determine the priority of Group A Registration of Intent for the selection of specified residential properties will take place on the First Date of Sale at the Designated Venue, and will be proceeded in 3 separate parts according to the description of paragraph 1.1 above (namely Part 1, Part 2 and Part 3 of Group A), one after one. For the avoidance of doubt, the balloting and selection of specified residential properties of Part 1 of Group A will take place first, followed by Part 2 of Group A and then Part 3 of Group A. The Vendor will post and announce the Attendance Registration Period of Group A Registration of Intent on the day before the First Date of Sale at or after 7:00 p.m. at the Ground Floor of the Designated Venue. The Vendor reserves the right at any time, for the purposes of maintaining order and/or facilitating smooth sale of the specified residential properties, to adjust the time and date of the balloting and/or Attendance Registration Period. Any changes to the time and date of the balloting and/or Attendance Registration Period will be posted on the Ground Floor of the Designated Venue and announced on the Development Website at www.kcity.com.hk ("Development Website"). Registrants will not be notified separately of such changes.

決定A組購樓意向登記揀選指明住宅物業之優先次序的抽籤程序將於出售首日於指定會場進行，並將根據上文第1.1段所述分為3個獨立部份（即A組第1部份、第2部份及第3部份）

一個接著一個進行。為免疑問，A組第1部份之抽籤程序及揀選指明住宅物業會首先進行，接著A組第2部份而A組第3部份將緊隨其後。賣方將於出售首日前一日晚上7時或其後於指定會場的地下展示及公布A組購樓意向登記於出售首日之報到時段。為了維持會場秩序及／或流暢地銷售指明住宅物業，賣方保留權利在任何時間調整抽籤程序及／或報到時段的時間和日期。任何抽籤程序及／或報到時段的時間和日期的修改會於指定會場的地下展示及於發展項目網站www.kcity.com.hk（「發展項目網站」）內公布。登記人將不獲另行通知該等修改。

- (ii). On the First Date of Sale, Group A Registrants shall personally attend the Ground Floor of the Designated Venue according to the Attendance Registration Period posted and announced by the Vendor pursuant to paragraph 4.1(i) above. Registrants must bring along his/her original H.K.I.D Card(s)/Passport(s) and the original receipt of the valid Registration of Intent for registration. Registrants who fail to register during the applicable Attendance Registration Period shall not be eligible to participate in the balloting.

- (iii). Group A Registrants who intend to participate in Part 1, Part 2 or Part 3 of Group A must personally submit a form prescribed by the Vendor for indicating which part of Group A they participate duly completed and signed by the said Registrants to the Designated Venue. The registration form will be distributed at the Ground Floor of the Designated Venue during the Attendance Registration Period of Group A Registrations of Intent on the First Date of Sale.

有意參與A組第1部份、第2部份或第3部份的A組登記人須於出售首天於指定會場親身遞交1份已填妥及簽署的賣方指定的表格以表示其參與之A組之部分，表格將於出售首天A組購樓意向登記之報到時段於指定會場的地下派發。

- (iv). The order of priority for selection of the specified residential properties in Part 1, Part 2 and Part 3 of Group A will be determined by balloting. Separate balloting will be carried out at the commencement of Part 1, Part 2 and Part 3 of Group A respectively. The following Group A Registrants will be included in the balloting of one of the above 3 parts:-

a. Group A Registrants who have indicated in their registration form to participate in Part 1, Part 2 or Part 3 of Group A will be included in the balloting of that part of Group A, provided that a Group A Registrant shall only indicate in the registration form to participate in one of the above 3 parts. If a Registrant indicates in the registration form to participate in more than one part, such registration form and the relevant Registration of Intent of such Registrant shall become void and shall be disqualified and such Registrant will cease to be eligible to select any specified residential properties in respect of that Registration of Intent.

b. Group A Registrants who have not selected and purchased any specified residential property in any of the above 3 parts will be allowed to participate in the subsequent part of Group A (if any). For the avoidance of doubt, the following Group A Registrants will **NOT** be allowed to participate in the subsequent part of Group A:

- Group A Registrants who have purchased specified residential properties in another part of Group A; or
- Group A Registrants who have selected specified residential properties in any of the above 3 parts of Group A but eventually do not enter into PASP of the specified residential properties so selected.

A組第1部份、第2部份及第3部份的揀選指明住宅物業的優先次序會以抽籤方式決定。獨立抽籤將會分別在A組第1部份、第2部份及第3部份開始時進行。以下A組登記人將被納入以上3個部份其中一個部份的抽籤：

The results of the balloting, including “registration number” and “ballot result sequence” of Group A Registration of Intent will be announced by the Vendor at the designated waiting areas in the Designated Venue. Registrants will not be separately notified of the results of balloting.

Group A Registrants shall comply with the rules set out in paragraphs 1.1 and 1.2 above and personally select and purchase specified residential properties which are still available at the time of selection in the order of priority according to the “ballot result sequence”, otherwise his/her order of priority shall lapse automatically and he/she will no longer be eligible to participate in that part of Group A; and

Group A Registrants shall select and purchase specified residential properties which are still available at the time of selection within a reasonable time, otherwise the Vendor reserves the right at any time, for the purposes of maintaining order and/or facilitating smooth sale of the specified residential properties, to cease his/her eligibility for selection of specified residential properties in that part of Group A but he/she will still be allowed to participate in the subsequent part(s) of Group A.

A組登記人須於合理時間內選購於當時仍可供揀選的指明住宅物業，否則為了維持會場秩序及／或流暢地銷售指明住宅物業，賣方保留權利在任何時間終止其於A組該部份揀選指明住宅物業的資格，惟該登記人仍可參與A組其後的部份。

- (vii). Subject to (viii) below, if the remaining specified residential property(ies) available for selection and purchase in a Part of Group A is less than the minimum number of specified residential properties that a Group A Registrant must select and purchase in that part of Group A, that part of Group A will end automatically and,

- a. Group A Registrants (other than those who have purchased specified residential properties in a Part of Group A or those who have selected specified residential properties in a Part of Group A but eventually do not enter into PASP of the specified residential properties so selected) may participate in the subsequent part of the Group A (if any); and
- b. The remaining specified residential properties will be offered for sale in the subsequent part of Group A (if any).

Each Group B Registration of Intent will be allotted with one lot. The results of balloting and the applicable Attendance Registration Periods of different Group B Registrations of Intent will be posted on the Ground Floor of the Designated Venue at or after 7:00 p.m. on the day before the First Date of Sale. Registrants will not be separately notified of the results of balloting. The Vendor reserves the right at any time, for the purposes of maintaining order and/or facilitating smooth sale of the specified residential properties, to adjust the time and date of the balloting and/or Attendance Registration Period. Any changes to the time and date of the balloting and/or Attendance Registration Period will be posted on the Ground Floor of the Designated Venue and announced on the Development Website. Registrants will not be notified separately of such changes.

Should a Group A Registrant eventually purchase more than 2 specified residential properties, such Registrant shall submit extra cashiers' order(s) drawn in the above manner to the intent that 1 cashiers' order shall be made available for part payment of preliminary deposit of 1 specified residential property so purchased by the Registrant.

- (ii) before signing the PASP in respect of the second and the subsequent specified residential property(ies), such Group A Registrant may request the Vendor on spot to:

- a. add one or more immediate family member(s) of any individual comprising such Group A Registrant as joint purchaser(s); or
- b. put one or more immediate family member(s) of any individual comprising such Group A Registrant as the purchaser(s) in the PASP, and omit the name(s) of any individual comprising such Group A Registrant from the PASP as purchaser(s).

provided that the relevant supporting documents must be provided to the satisfaction of the Vendor to prove the relationship(s) with such immediate family members.

5.6. “Immediate family member” has the same meaning given to that term under the Residential Properties (First-hand Sales) Ordinance, i.e. “immediate family member”, in relation to an individual, means a spouse, parent, child, sibling, grandparent or grandchild of the individual.

Notwithstanding anything herein contained, the following provisions apply to the selection of specified residential properties on the First Date of Sale: When it is the turn for a Group B Registrant to select a specified residential property in respect of a Group B Registration of Intent, that Group B Registrant (the “**Registrant Concerned**”) may, in addition to making that selection, opt for having the selection of specified residential property in respect of a Qualified Registration of Intent of that Group B Registration of Intent with a lower priority to be made at the same time. “Qualified Registration of Intent” means any other Group B Registration of Intent if the Registrant under that other Group B Registration of Intent or any person constituting that Registrant is the Registrant Concerned or any person constituting the Registrant Concerned. For the avoidance of doubt: (i) only specified residential property(ies) available for selecting may be selected; (ii) the purchaser(s) of any additionally selected specified residential property(ies) shall be the Registrant of the relevant Qualified Registration of Intent, subject to paragraph 5.4 above; and (iii) the above provisions does not apply to any Group A Registrant.
